Saat ini, Bapak Troy menjabat sebagai Chief Financial Officer (CFO) Perusahaan. Sebelumnya, beliau menjabat sebagai Group CFO di PT Wahana Nusantara Rucika, di mana beliau berhasil memperoleh fasilitas pinjaman modal kerja sebesar IDR 1 triliun melalui sindikasi perbankan serta membentuk kemitraan strategis untuk mendukung pembiayaan perdagangan.

Mr. Troy currently serves as the Company's Chief Financial Officer (CFO). Prior to this role, he was the Group CFO at PT Wahana Nusantara Rucika, where he secured working capital loan facilities totaling IDR 1 trillion through a syndicated banking arrangement and established a strategic partnership to support trade financing.

Sebelumnya, beliau juga menjabat sebagai Group CFO dan anggota Dewan Direksi di PT Mitra Pinasthika Mustika Tbk. Selama masa jabatannya, beliau berperan penting dalam proses penawaran umum perdana (IPO) perusahaan, menerbitkan Global Bond senilai US\$150 juta pada tahun 2014, serta berhasil mengatur fasilitas pinjaman sindikasi dua tranche sebesar US\$150 juta dan IDR 1,25 triliun pada tahun 2017.

Previously, he also held the position of Group CFO and was a member of the Board of Directors at PT Mitra Pinasthika Mustika Tbk. During his tenure, he played a key role in the company's Initial Public Offering (IPO), issued a US\$150 million Global Bond in 2014, and successfully arranged a dual-tranche syndicated loan facility comprising US\$150 million and IDR 1.25 trillion in 2017.
